White, reactive and disperse dyed woven fabric produced from CO, LI, CLY, CV, CO/EL, CO/LI, CO/HA, CLY/CO, CO/HA/EL, CLY/CO/EL, CLY/CO/LI, CLY/CO/HA, CO/CV/EL, CO/CV/LI, CO/LI/EL, CLY/CO/LI/EL, CO/PES, CO/PES/EL, CV/PES/EL, CO/PES/CV/EL, CLY/PES/CO/EL, CLY/PES/CV/EL, CO/PES/HA/CV/EL, CO/PA/EL, CO/CLY, CO/CLY/EL, CO/CLY/LI, CO/CV/PES/EL (PES part raw) and bleached woven fabric produced from CLY, HA and mixtures with CO, LI, CV, PES, EL and raw woven fabric made of CO/WO, indigo and sulphur dyed woven fabric (also wash out) produced from CO, CO/EL, CO/PES/EL, CO/CLY/EL, indigo blue, blue, blue/black, black over dyed, sulphur black mercerized, coated, calendered and sanforised as well as greige and non-denim fabric produced from CO, CO/EL, CO/PES/EL, reactive, pigment (also matt white) and glitter (silver and gold) printed woven fabric produced from CO, CO/EL, CO/PES/EL as well as pigment printed woven fabric made of CLY and digital reactive and digital pigment printed woven fabric produced from CO, CO/EL, CV, CO/PES/EL, CO/PES/CV/EL with or without hot stamping foils (stamping foil and crystal foil), transparent gold, silver and coloured with or without aluminium metallizing, adhesive or releasing adhesive produced from CO, CO/EL, CO/PES/EL; produced by using materials certified according to STANDARD 100 by OEKO-TEX®.


The results of the inspection made according to STANDARD 100 by OEKO-TEX®, Annex 4, **product class II** have shown that the above mentioned goods meet the human-ecological requirements of the STANDARD 100 by OEKO-TEX® presently established in Annex 4 for products with direct contact to skin.

The certified articles fulfil requirements of Annex XVII of REACH (incl. the use of azo colourants, nickel release, etc.), the American requirement regarding total content of lead in children's articles (CPSIA; with the exception of accessories made from glass) and of the Chinese standard GB 18401:2010 (labelling requirements were not verified).

The holder of the certificate, who has issued a conformity declaration according to ISO 17050-1, is under an obligation to use the STANDARD 100 by OEKO-TEX® mark only in conjunction with products that conform with the sample initially tested. The conformity is verified by audits.
